



We ended 2013 on a high note, with the U.S. Department of Agriculture launching an Energy Efficiency and Conservation Loan Program inspired by Help My House, a project EESI helped get off the ground in South Carolina. The Help My House project embodies the win-win solutions that EESI advocates, and shows how local initiatives can have nationwide impacts.

At the end of 2013, we were also delighted to receive another 4-Star rating, the highest possible, from Charity Navigator for the 7th time in a row—a feat only two percent of the 5,500 nonprofits they rate have achieved. We were particularly proud to secure a perfect score for our accountability and transparency measures.

Earlier in the year, our partnership with the U.S. Department of Energy, the Association of Public and Land-grant Universities, and the University of Maryland came to fruition with the unveiling of Energy 101. This freshman-level course framework aims to make our future leaders and citizens fully aware of energy and sustainability issues.

I'm delighted to note that 2014—which marks EESI's 30th anniversary—is shaping up to be just as successful! We are ramping up our rural energy efficiency program. We've started a new fundraising partnership with Suja Juice, which produces healthy, sustainably-sourced beverages. And, we've launched a new website to make it easier for you to find the information you're looking for, and share it with others.






Financial Overview
